## Malaysian Oil and Gas Service Provider takes 9.86% stake in Triangle

Triangle Energy (Global) Limited (**Triangle**, the **Company**) is pleased to announce that Malaysian Securities Exchange listed T7 Global Berhad Company (**T7**) has taken a 9.86% strategic stake in the Company. T7 has purchased 16.476 million shares from Tamarind Classic Resources Private Limited (**Tamarind**) for consideration of USD 500,000.

Tamarind has a Convertible Loan Agreement (**Loan**) with Triangle for USD 1.215 million and converted USD 439k of that Loan at AUD 0.04 to facilitate the purchase by T7. The balance of the Loan outstanding is USD 776k.

Triangle's managing director Mr Rob Towner said he was delighted to have T7 and Tamarind as strategic investors in Triangle.

"We have extensive plans to develop both Cliff Head and other Perth Basin opportunities. Their knowledge and expertise will assist us in achieving our goals.

"Since taking over operatorship and a majority 78.75% interest in the Cliff Head Oil Field, including the onshore Arrowsmith Stabilisation Plant, we have achieved significant cost reductions in our operations. Retaining more cash from production is allowing us to direct funds towards development opportunities." Mr Towner said.
